What follows is a description of the information we collect and disclose, including the parties who receive nonpublic information from us as we conduct the business of the credit union:

Information We Collect About You

We collect information about you from the following sources:

- Information we receive from you on applications and other forms;
- Information about your transactions with us or others;
- Information we receive from a credit reporting agency;
- Information obtained when verifying the information you provide on an application or other forms.

This may be obtained from your current or past employers, or from other institutions where you conduct financial transactions.

Parties Who Receive Information from Us

We may disclose nonpublic personal information about you to the following types of third parties:

- Financial companies, such as insurance companies and mortgage service companies; and
- Non-financial companies, such as consumer reporting agencies and retailers.

Disclosure of Information to Parties that Provide Services to Us

We may disclose all of the information we collect, as described above to the companies that perform marketing or other services on our behalf or to other financial institutions with whom we have joint marketing agreements. As a result of these arrangements, we may disclose all of the information we collect, as described above.

If you wish to opt out of disclosures to nonaffiliated third parties, you may phone or write P.I.E. Credit Union.

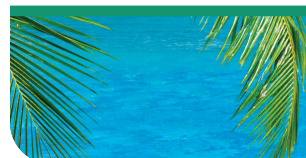
