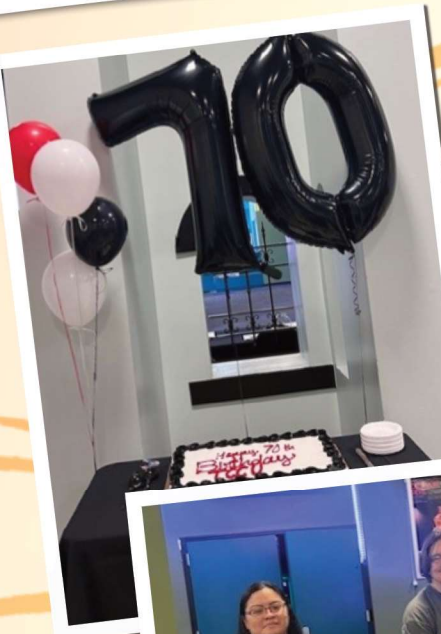

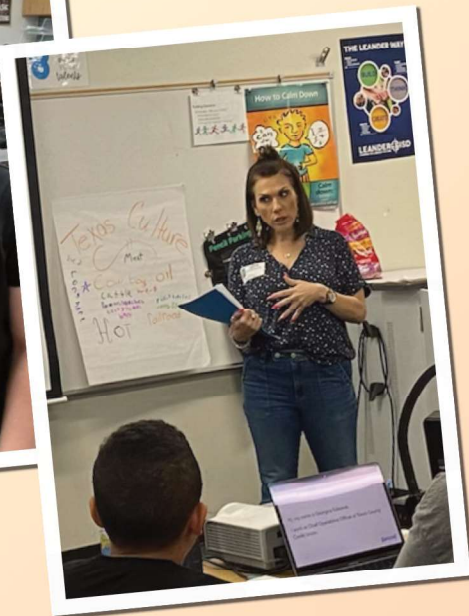
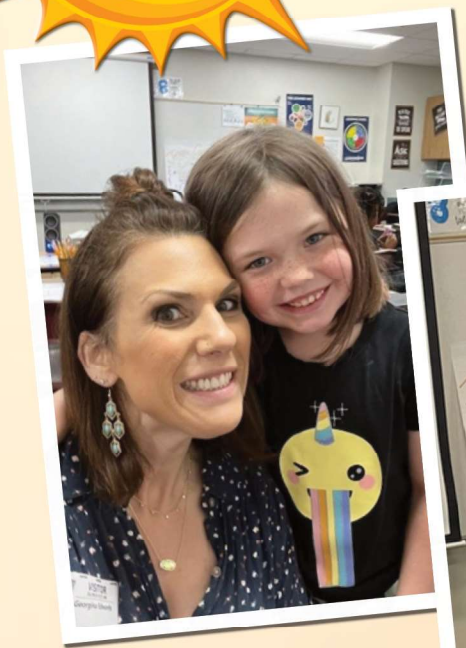

# FRAUD ALERT!

## ATM AND CARD READER SKIMMERS

Financial institutions nationwide continue to see a substantial rise in the presence of ATM and card reader skimmers. Skimmers are modified card readers placed over the top of the card reader or the ATM to capture and steal card data. The card and PIN data is then used to create fake cards or conduct fraudulent transactions online.

To protect your cards and prevent card data theft, we recommend you review the steps below and continue to educate yourself about skimmers and how you can help in the fight to prevent them.

- Check ATMs for skimming devices or evidence of tampering before inserting your card.
- Look for small, hidden cameras around the ATM that may be pointed at the keypad.
- Ensure you only use ATMs that are well-lit.
- Utilize transaction/balance alerts to help you stay aware of account activity.

### **As always, please:**

- Report any suspicious card reader or ATM devices to local authorities.
- Report compromised cards immediately.
- Protect your PIN by covering your hand as you enter it in any type of machine.
- Monitor your account(s) regularly and report any suspicious activity immediately.
- Provide us with notification of upcoming travel plans where you will be using your cards.
- Always protect your card number(s).

## ACCESS TO CREDIT UNION DOCUMENTS

In accordance to Section 91:315, this notice is to advise you, as a Travis County Credit Union member you have to the ability to request certain documents relating to the credit union's finances and management.

These documents are: the balance sheet and income statement, a summary of the most recent annual audit, written board policy regarding access to articles of incorporation, bylaws, rules, guidelines, board policies, and copies thereof, and the Internal Revenue Service Form 990. Any requests for these documents should be made to management at our main office with advance notice.

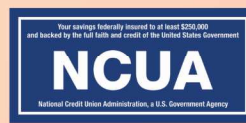
